Investing in the City's competitive edge

In October the Square Mile kicked off a season full of events leading up to Christmas with a spectacular immersive family friendly theatre day and one of London's biggest free events: The Golden Key. 30 independent theatre companies and 200 performers attracted thousands of people into the City with a giant extravaganza of fun. The event officially launched a new 'Destination City' programme.

Over the next five years, the Square Mile's key challenge can be distilled into one word: competitiveness. Whether ensuring we have the best City for our nine-thousand residents, our half-a-million workers, or our 22,000 businesses, remaining fiercely competitive as a destination to live, work, and play should underpin all we do.

Financial and professional services firms for example contributed nearly 100 billion pounds in taxes in 2020, providing over 13 per cent of the UK's total tax revenue.

And FPS firms employ over seven per cent of the UK workforce, 2.3m people, two-thirds of whom are outside London. It is, therefore, in the interests of the whole nation for this industry to succeed.

Within the overarching ambition to be as competitive as possible we have outlined three priorities: Destination City, green City, and tech City.

Based on extensive feedback, Destination City seeks to establish a new vision for the City as a leading location for visitors, workers, and residents. Our objective is an ambition to create an exceptional leisure offer anchored to the City's identity.

For our second priority we want the City to be a worldleader in the net zero transition for built environment - the reimagining of the old BT centre in the Ward of Cheap is a great example reusing as much material as possible and a global hub for green finance.

The third priority is for us to be a tech City, a place supported by world-leading technologies, strengthened by transport investment, securing more tech businesses in the Square Mile.

Construction begins on justice and policing hub

The City of London Corporation, the Ministry of Justice and the City of London Police have celebrated the start of construction on a 45,785 sqm civic scheme to boost the justice system's work to crack down on fraud.

Funded and delivered by the City Corporation, the Salisbury Square Development on Fleet Street will house the City of London Law Courts and a state-of-the art headquarters for the City of London Police and is due to be completed in 2026.

With 18 courtrooms, the City of London Law Courts will combine magistrates, civil and crown courts in one flagship facility. The courts will harness new technology and modern ways of working to try economic crime cases.

As the lead force investigating cyber and economic crime nationally, the new headquarters will equip the City of London Police with the tools needed to face the challenges of 21st century policing.

Home to 2,500 jobs – 400 of which will be newly created – the scheme will generate an estimated £51m in productivity benefits (Gross Value Added) per year.

Green light for refurbishment plan

The City Corporation has resolved to approve the refurbishment and extension of Cripplegate House, which will create 15,471 square metres of high-quality, Grade A flexible office floorspace together with a new community and cultural space.

The refurbished and extended building at 1 Golden Lane – proposed by Castleforge – will add an extra 2,485 square metres of space to the existing site to meet continuing strong demand from occupiers in the Square Mile.

The scheme will form part of Culture Mile, with the community

and cultural space at ground level set to be combined with new public artwork and murals around the site. This will be accompanied with other public realm and lighting enhancements around the site.

It will be designed to high sustainability standards, incorporating a significant element of integrated urban greening, climate resilience and energy efficiency. The scheme targets BREEAM 'Outstanding' and adopts Circular Economy principles. A total of 222 long stay and 14 new short-stay cycle parking spaces will be provided to encourage active travel.

Artist Matt Small's paintings, which are on loan from Moniker Foundation and managed by JG Contemporary, will be on display in the Temple Room at the gallery.

The artworks celebrate the diversity of what it means to be English today and recognises the players' superb teamwork and admirable stance on equality, inclusivity, and racial injustice.

Statement of community involvement

The City Corporation is to ask people for their views on a new Statement of Community Involvement setting out how engagement and consultation will take place with the Square Mile's communities on planning applications and planning policy matters.

The revised Statement of Community Involvement replaces one previously agreed in July 2016. It incorporates consultation and engagement lessons learned during the pandemic, when new and innovative ways to communicate with stakeholders were introduced effectively.

This includes making provision for online and hybrid meetings and consultation events, the use of new presentational techniques such as 3D modelling and the use of QR codes. These will be utilised alongside more traditional methods to increase engagement in planning matters.

The City Corporation continues to encourage developers to consult with local communities ahead of taking their proposals forward by submitting a formal planning application. To ensure this is done well, draft guidance for developers on the City Corporation's expectations has also been prepared for consultation.

Both the Statement of Community Involvement and the developer engagement guidance will be issued for public consultation then brought back to the Planning and Transportation Committee for further consideration and formal approval.

Our work as elected representatives

As Alderman and Common Councillors for the Ward of Cheap we have continued our work representing businesses and residents in our ward, and promoting the Sauare Mile more widely.



We represented the Ward at the Exclamation of our new King at Royal Exchange Robert Hughes-Penney spoke at the launch of the Cheapside Business Alliance annual report. He said, "The launch of the City's new Destination City programme is expected to shift perceptions about the Square Mile, attract new audiences and ensure the city evolves to remain a world-class destination, aligning well with aspirations of CBA."



Alastair Moss is leading work to make the City Corporation a more attractive organisation to work, strengthening EDI initiatives and recruiting a new Chief Executive.
